Archives Chair: Kathy M. reported The Archive Committee meets at the Jackson Fellowship on the 1st Wednesday of the month from 2:00-4:00 p.m. We presently have 8 members and one at-large member.

The Committee is presently working on a Collection Scope (what is and isn't stored in the Archives) and have several questions for District 30. We are concerned about our limited space for storage and would like to purge the archives of old financial records and any other items that are deemed not archival material or irrelevant.

Our questions are:

- 1. Are we a non-profit 501(c) (3) organization? If so, we would need to be careful about what is stored for that purpose.
- 2. Do we have the Right of Decision in making decisions about what is stored in the Archives?
- 3. Can we store only year-end financial records and budgets, which are important to the Archives?
- 4. Finally, we wanted to know if there is a written policy already for what District 30 stores in the Archives?

The Archive Committee will review the results of today's District meeting at our next Archive's monthly meeting and will report back on the results of the Collection Scope decisions.

We have identified the next 7 groups to be contacted for their group histories for presentation at 2018 Unity Day.

The Gold Country Roundup Archive presentation format will remain the same for 2018: An update on the Archives, a History of the Roundup and elders who tell anecdotal stories about past Roundups.

We are still looking for a venue in Calaveras County for the Annual Archive History Day. A possibility is the Scout Hut in Murphys. Kathy is working with Tish on this venue.

The Archive Committee continues to seek and create narratives for group and individual histories within District 30. We have several group histories completed now and our first individual history for Vince K, a long-time, service-minded elder member of AA.

Grapevine Chair: Earl F. reported he has taken Grapevines to meetings and his time is now up. There is not much activity.

Gold Country Roundup Liaison: Dorothy S read report from Deborah indicating a meeting next Wednesday December 13in Jackson. Deborah will remain as Chair. Dorothy was the GCR Treasurer.
