Dale (Sierra Fellowship) we need to adopt a budget – all we need to do is request proposed budget estimates from the trusted servants, line it up to the historical income and base 2019 budget projection on this.

Motion: Dale – a report from the finance chair will be brought to the February meeting with any increases, decreases to the budget or whatever Garrett has presently as a budget. Second Andrew – motion carried.

Meeting Schedules for Next Printing – Dave reported that deadline for changes will be January 4, 2019. Del received text from Dave L that he has car troubles and will not be in attendance today. However, the printer is printing our new schedules this week and he will bring new schedules to the next district meeting.

Archivist: Kathy M. – the Archive Committee did not meet for its monthly meeting on 1/2/19 due to illness. The Archive Committee meets on 1st Wed of the month at 2:00 p.m., at the Jackson Fellowship. Since we did not meet, there is not much that has changed since last month. Archive History Day for 2019 is in the planning stages. We have a date, a venue and speakers, as well as David L's (Sound Solutions) archival collections. As the event develops, more will be reported to the District. We continue to ask the GSR's to go back to their group to announce the event in May/June. Asking for volunteers can be done earlier to help set up and clean up for the event or oversee food and coffee. A flyer for volunteering will be given to each GSR a few months before the event with a request to give the volunteer information to Ralph H, an Archive Committee member. His contact information will be provided at a later date.

The Archive Committee will meet in February and continue our planning for the upcoming Archive History Day, and our reorganization of the Archives also continues.
