Susan and Steve can resolve. Steve will receive copies of the bill. Per Susan, telephone bill back to its normal amount. Our spending plan has been submitted — all is good. Donna at San Andrew Town Hall will return District 30's checks. Everyone is canceling at their facility.

PI/CPC Chair: Del M.: Had a Zoom meeting after last district meeting. Discussed two things – (1) continuing to have public service announcements at KGVC Radio station but announce some meetings are now open and (2) printing business cards. Del will approach KVGC about the change in meeting status. In the past, the PI committee had business cards printed up m- "If you want to drink that's your business, if you want to stop, we can help." GSR's will be given a supply. Need a motion to have 2000 cards printed to begin with, over and above PI budget. He will investigate how much this will cost. Motion to investigate cost – Steve/Michael – motion carried. Next PI Committee meeting on Zoom -Wednesday, June 17, 2020 at 6:00 p.m. Del and Kathy will move to Sonora soon and he will continue his PI term.

meeting arrangements, including any more that might want to be listed, so I can keep everything up-to-date. **Archivist**: **Kathy M** – The Archive Committee met on June 3, 2020 via Zoom and discussed the following: Archive History Day has been canceled. Jim B, Archivist from Akron Ohio, informed he will be undergoing an operation and will not be able to travel here. Also, due to the pandemic, we were contemplating canceling this year's Archive History Day anyway. However, our August 2021 Archive History Day is still being planned, with Father Tom W from Oakland as our main speaker. Kathy will rotate out as Archivist in January 2022. Marc W has been voted in via the Archive Committee to be the Alternate Archivist. The District was informed of this proposed new position and was asked to vote on changing the By-Laws for the District to include this new position. Kathy will develop language for the revision in the By-Laws and present to the District at our July meeting for discussion and possible voting. Group histories continue to be written. Kathy does not presently have a key to the Jackson Fellowship, so we cannot access the archives. A key will be sought. When the key is obtained, work can commence on the reorganization of the District's Archival files stored at the Jackson Fellowship.
