Historical Factoids for the Month

1912 - September, at the start of his senior year at Burr and Burton, Bill W was class president, star football player, pitcher and captain of the baseball team and first violin in the school orchestra.

1915 - September 11, Bill and Lois were secretly engaged.

1930 - September 3, Bill W wrote his last pledge to stop drinking in the family Bible: "Finally and for a lifetime, thank God for your love." After that, he gave up making promises in despair.

1939 - September 30, in the late 1930s and early 1940s public relations had the most dramatic impact on AA membership growth. Liberty Magazine, headed by Fulton Oursler, carried a piece titled "Alcoholics and God" by Morris Markey. He was influenced to write the article by Charles B Towns.

1946 - September 12, a dispute arose over a funding solicitation letter from the National Council for Education on Alcoholism by Marty M. Dr Bob and Bill W's names were on the letterhead. The Alcoholic Foundation issued a letter and an October Grapevine article to disavow AA affiliation

1952 - September, Al-Anon adopted and adapted AA's Twelve Traditions.

1954 - September 17, Bill D (AA #3) died.

2001 - September 12, AA trusted servants of NY Area 49 and the NY Intergroup Office organized AA meetings around the clock near Ground Zero for AA members engaged in rescue and emergency work at the 9/11 World Trade Center disaster.

 - o Minority Opinion: It was stated that many do not have the ability to read and understand the language of the Big Book. This is a deterrent for those who will not ask for help. One member asked to change his vote after Minority Opinion. With that 8/3 vote, the District opened discussion of the letter. It was decided as all had not actually received a copy of the letter that it would go back to groups for group conscience of whether or not the District as a whole should support the letter. Also, the groups have been given permission to use the letter for their group's conscience to Area or GSO if they so choose.

New Business:

- Request for possible use of excess funds
 - o Greg N. gave information on the possibility of advertisements being placed on the public transit buses. "If you want to drink that's your business, if you want to stop that's ours" AA and phone number. Cost would be \$175 per add, per month, per county as they are two different public transit divisions. Someone requested the District 30 bring back the Gould Country Round-Up, we talked about that NOT being a District event, and that the GCR had dissolved last year as there was no one interested in reviving/chairing/running the event. And that it was a separate 501-C3. Another member asked if we could set aside \$350 to help support GSR's to Assemblies. It was then discussed that the District currently has a plan for scholarships to the Assemblies. Next month we will finalize the list for the Finance Committee.

Trusted Servants and Committee Reports:

DCM: Titia A Panel 72: I attended the July ACM meeting via Zoom on July 15th, 2023. Due to a heat warning of 108 in East Yolo County, and limited air conditioning at the ACM. We took a group conscience and decided we would move the Delegates Report to 12:00p and after that we would disperse early. There was a question for H&I as some have been told not to put \$ bills in the pink can. Vicky Ray the Area H&I Liaison said that as H&I has expanded their services, all contributions be it coin, or paper are appreciated. Also of note, the contribution to H&I are for their service structure including providing literature to those who cannot get out to meetings. There was a motion made to hire a bookkeeper to assist the Area Treasurer. The cost is approximately \$250 per quarter. Motion Passed. Claudio our Area Chair has not yet been able to get additional information from the church about rent increase or our ability to stay longer (another year lease). There was a discussion with the Area Finance Committee about the next spending plan. The Area spending plan runs on a calendar cycle from January to December and a new Spending plan should be approved at the Winter Assembly, the 3rd weekend in January. The Area needs to cut approximately 38% of their current expenditure to match current income (contributions). Questions to think about, does Area need to send all the chairs to PRAASA and the Forum? Other ideas to help cut spending would be appreciated. Our Delegate gave a short report via Zoom as she was on vacation with her family.
