Old Business:

 Meeting Schedule Print Run – Carole S. reviewed new format of a smaller card stock with a QR code. Received two quotes for \$560 and \$516 (Staples). We reviewed the single

- page content. We asked that the draft version be circulated prior to printing. Have not decided on who will create the flyer. Motion (Greg/Randy) to create a rough draft by June meeting (including potential cost).
- Delta Intergroup PI/CPC Communication —
 Harry talked with Melanie @ Delta. They did
 not have too much information on the process
 of working with different institutions. We will
 continue to work with the probation
 departments as main point of contact. Also
 discussed options on reducing our telephone
 costs. We discussed that the goal would be to
 drop our hotline service and that calls would be
 directed to the Delta Intergroup. Harry to
 revisit this topic with Melanie.
- Finance Committee 2023 Budget The proposed budget was circulated at the meeting. Each GSR needs to bring this back to the groups for review and approval. Feedback is expected by June D30 meeting. We are projecting a \$3356 shortfall for 21/22. Also discussed expense reductions for storage, phone costs, and travel. It was noted that Archivist budget will need to be changed.
- Unity Day Update Pat H will be stepping up to help with cooking. All speakers have been lined up. Everything is ready for the event.
- Gold Country Round Up Inventory This issue has been taken care of. Surplus items are now in the Unity Day inventory. Items of historical interest have been donated to archives.
 Remaining funds from GCRU will be donate to D30. It was noted that GCRU should not be considered an outside entity and that most of these funds would be considered 7th tradition. It was voted to accept the donation.

• Archives Move and Update – The archive committee has met on the phone and in person to discuss the archives and to plan the move from Sonora storage to Angels Camp storage. As of May 12, 2022 we are officially moved out of Sonora and moved into Angels Camp storage. This move would not have been possible

Also want to acknowledge Dennis and Laurie, Terri & Nancy for their time spent going through the Archives with me. I appreciate your willingness and time. Look forward to our projects in the future. We are asking District 30 to approve the three extra bank boxes at the El Dorado Savings Bank in San Andreas Ca. This will insure our archives safe keeping. The cost for each box is \$ 75.00 and a key for each box. The total per year will cost District 30 \$300.00 (total 4 bank boxes).
