#### **Old Business:**

- Meeting Schedule Print Run Grace presented next version. This has a QR code which is free for us to use. The QR code links to the web site. Did a print run of 500 for \$110. These were distributed to the GSRs. It was suggested that the website version with the complete meeting list may be printed and delivered to different meetings.
- Delta Intergroup Hotline Usage Randy spoke with Lynne of Delta Intergroup Central Office and Billy Rutherford, Help Line Coordinator. Both expressed enthusiasm for D30 participation:
  - Delta office open 12-5P.M. Tu, Wed, and Th staffed by volunteer Lynne.
  - Office operations and policies are governed and established by an Intergroup Council which meets in person and on Zoom the

- second Wed of each month at 7P.M. in Stockton. Address: 1525 N. El Dorado Street #3
- A District Representative to this meeting would be greatly welcomed and appreciated.
- Lynne attended D30's recent Unity Day and frequently travels to deliver ordered literature to the Sonora Alano Club. Delta order books in bulk to save meetings shipping charges.
- Billy Rutherford has maintained the Help line for several years as an ongoing service commitment. This Help line uses the Delta Intergroup web site meeting listing to provide meeting information.
- Shifts are every 4 hours, once a week and currently are full. Billy maintains two registries; call answering and information and also available Twelfth Steppers.
- He welcomes D30 members available to take a Help line shift when an opening occurs. He would very much appreciate having a 12th Step call sheet for Amador and Calaveras Counties.
- 2022 Actual Expense Report Randy presented FY 21/22 budget vs actual report with annual numbers. Total budgeted revenue = \$3600. Total budgeted expenses = \$11067. Actual revenue = \$11922. Actual expenses = 10421. Excess = \$1500. This included income from Gold Country Round Up and Unity Day.
- Finance Committee 2023 Budget Randy reviewed the new budget for 2022-23. New budget does not include Hotline, assuming that we will use Delta. But it does include \$1400 for meeting directories, which may reduce this number. Motioned that \$330 will be allocated to directories. Add in \$800 for PRAASA attendance. Delta Intergroup donation for \$50 per month. Greg seconded. Motion amended to bump up the directory costs \$500. The budget passed. The current budget expenses will exceed revenue for this next year. Note the GSR expense form is posted to the D30 web site. It was suggested that we publish a "What does District 30 Do?" flyer to promote our services.
  - Final Budgeted Income = \$7230, Budgeted
     Expenses = \$10328, Shortfall = \$3097
