#### **Old Business:**

 District Guidelines – Suggested that we add a section that documents signature requirements for bank accounts, safe deposit boxes, storage lockers. • CNIA Area 07 Mini PRAAS Service
Assembly – Reported that it was a good event.
It was noted that some of the items that was discussed have already been voted on a while back. There was a lot of discussion on the budget. There was a concern of ongoing expenses that were paid out of surplus from the last two years. Will Area be able to revise budget downwards in future years.

#### **New Business:**

- District 30 Zoom
  - Discussed moving back to full time during the winter months. General consensus was no.
  - Hybrid format Recommended to continue with hybrid meetings. There was some concern about the DCM or the Alt-DCM not being able to open the doors due to weather.
  - Discussed adopting Zoom group expense. Mike C. has been donating cost of Zoom subscription for 2022. Susan R motioned to reimburse Mike C. for the remainder of the 2022-23 panel. Cece seconded. Motion passed.
- Area Assembly 2024 Pre-Conference This would be the third weekend of Oct. Susan R researched more requirements while at PRAAS. There are a lot of requirements in order to host the event. Discussed partnering with D33 Toulumne and the Hispanic districts. This would be more "doable" if we get extra support. Titia and Susan will follow up with the other districts to gain support.
- Secretary Workshop Discussed the possibility of hosting more workshops at the District level similar to pre-covid events. Will add this to new business for Dec.
- The District 30 Dec meeting will be potluck brunch format.

#### **Trusted Servants and Committee Reports:**

**DCM: Titia A Panel 72**: No update. Was not able to attend the PRAAS event.

**ALT DCM**: Greg N – I attended the Mini PRAASA that was held at the Yuba Sutter County Fairgrounds this last weekend October 14 - 16, 2022. Below is my report. There were a couple of Panels that our very own Susan

participated on. They were pretty good and had some great information.

The meat of the Assembly was spent on discussing and finally passing the Area 7 Spending Plan for next calendar year (2023). A final copy is expected to be available from the Area Treasurer soon. The amended Spending Plan totals to about \$106,105.00 for the upcoming year. There were about 4 members of the Area (members are defined as Area Officers and Appointed Chairs, DCM's GSR's or their alternates) that voted against the Plan. The Minority Opinion was heard and there was NOT a motion to reconsider. The Motion was carried and we now have a spending plan for next year.

There was also that motion that we have been discussing at our Group Level and at the District Meeting as well. The motion identified and asked that the Area Finance Committee be able to spend up to 20% of the funds in excess of the prudent reserve at the time of the approved spending plan for the year". That motion has been active since the Winter Assembly earlier this year. It was discussed for a bit and there was substantial unanimity to vote on this and the motion did pass. There were 3 folks that voted against the motion and they were given the opportunity to state their reasons why they did so, they declined and the motion was carried.

The Area also conducted an Inventory at this Assembly. The following questions were asked and there was quite a bit of discussion at the microphone:

- How can our Area become more receptive to change?
- How can the Area support all Districts to grow and participate in ways that make sense for their unique geographic locations, meetings, and members? Do we support all members to participate in service events and activities?
- Do I have a good understanding of the Area's primary purpose? Does our spending plan reflect and support the priorities? Do we make efficient use of our 7th Tradition contributions, resources, time, energy, knowledge?

 How effective and useful is the two-way communication between the Area and districts? How can the Area support Districts, Groups and GSRs to use the Traditions, carry the message, and fulfill their primary purpose to reach the stillsuffering alcoholic?

There was some very healthy discussion and the Area will be taking a hard look at some of the responses.
